To Whom It May Concern:


I spoke this afternoon with Megan and Michelle (I hope I'm spelling your names correctly) regarding my corporation, Jeffrey L. Rabin, D.C., P.A., and the fact that I wished to obtain an exception to the late fee assessed for not filing by May 1, 2000.

As I explained to Michelle, before she explained to me that I needed to write a letter, my wife had assured me that the UBRs for my personal corporation, Jeffrey L. Rabin, D.C., P.A., and my other corporation, ChiroHabitat, had been sent in on time. As your records may show, I discussed with Ms. Kathy Ashton on June 28, 2000, a question regarding the FEI number for ChiroHabitat. I remember discussing this with my wife at that time. My wife honestly believed she had filed the UBRs for both corporations at the same time, in April, using the same envelope. In fact, she had not.

Now I could lie and say we never received the first report request, or that there was a death in the family, but we did and thankfully there wasn't. The fact is that both my wife and I were and are a little overwhelmed by juggling the demands of a new business with our present family commitments, stresses and other demands. Not to say that my kids aren't the most patient and understanding of all children, but they are still just 3 and 6 years old.

I don't know whether "overwhelmed" qualifies as cause for an exception, but I can tell you as a chiropractor that it's not that far from illness, which, Michelle tells me, does qualify as cause for an exception. And I do know that there are fewer shades between overwhelmed and ill than there are between violet and indigo. Your understanding in this matter would be greatly appreciated, as the \$400 late fee would be an additional strain on people who are already somewhat overburdened, as the failure to file on time demonstrates.
