



ARTICLE ONE

The name of the corporation is **SIGN FACTORY INC** The principal address of the corporation is:

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100)** of no par value.


ARTICLE FIVE


ARTICLE EIGHT
