In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

Article I

The name of the corporation ("Corporation") is **PINNACLE GOLF MANAGEMENT, INC.**

Article II

The existence of the corporation shall begin on **MARCH 19, 1997.**

Article III
