ARTICLES OF INCORPORATION

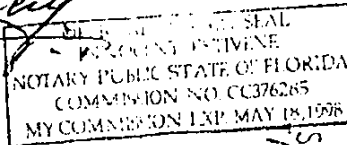



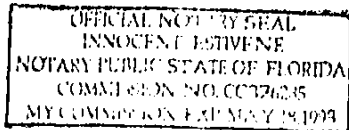
