The dissolution was authorized on January 12, 1998.

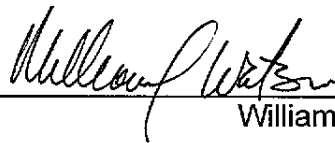
**ARTICLE III**
