# ARTICLES OF INCORPORATION

**OF** 

JOSEPH'S BAGELS & ITALIAN DELI, INC.



#### **ARTICLE I - NAME**

The name of this corporation is JOSEPH'S BAGELS & ITALIAN DELI, INC.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on the date of execution of these Articles.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida.

# ARTICLE IV - CAPITAL STOCK

At each election for directors, every shareholder entitled to vote at such election shall have the right to vote, in person, or by proxy, the number of shares owned by him for as many persons as there are directors to be elected at that time and for whose election he has a right to vote or to accumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing such votes on the same principal among any number of such candidates.

Section 2. <u>Pre-emptive Rights</u>. Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof as nearly as may be done without issuance of fractional shares at the price at which it is offered to others.
