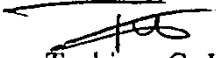

The name of the corporation is: **MURMANSK DEVELOPMENT
CORPORATION, REGIONAL AND INTERNATIONAL**

ARTICLE II; DURATION

This corporation shall exist perpetually, commencing on the date of the filing of these Articles of Incorporation.

ARTICLE III PURPOSE

This corporation is organized to transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. 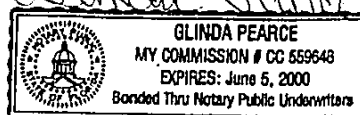
