ARTICLES OF INCORPORATION

**ARTICLE I. NAME**

The name of this corporation is ANGLE ALUMINUM, INC.

**ARTICLE II. PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE III. CAPITOL STOCK**

This corporation is authorized to issue 600 shares of \$1.00 per value common stock.

**ARTICLE IV. PREEMPTIVE RIGHTS**

Every shareholder, upon the sale for cash of any new stock in this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at a price at which it is offered to others.

**ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT**
