Par Value Common Stock, which shall be designated "Common Stock".

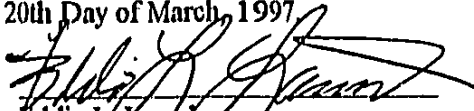
ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE V - INITIAL BOARD OF DIRECTORS

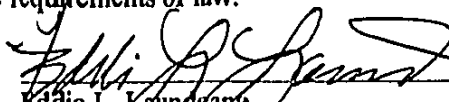
This Corporation shall have two (2) Directors initially. The number of directors
