

ARTICLE I - Name

The name of this corporation shall be THOMAS SILVER CONSTRUCTION, INC.

ARTICLE II - Duration

This corporation shall exist perpetually.

ARTICLE III - Purpose

This corporation is organized for the purpose of constructing and restoring buildings and for the purpose of transacting any and all lawful business.

ARTICLE IV - Capital Stock

This corporation is authorized to issue One Hundred Thousand (100,000) shares of Ten Cents (10¢) par value common stock.

ARTICLE V  
Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 2846 San Fernando Road, Jacksonville, Florida, 32217, and the mailing address is the same. The name of the initial registered agent of this corporation is Thomas C. Silver at that address.

ARTICLE VI - Initial Board of Directors

At each election for directors every shareholder entitled to vote at such election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing such votes on the same principle among any number of candidates.

ARTICLE IX - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price which it is offered to others.

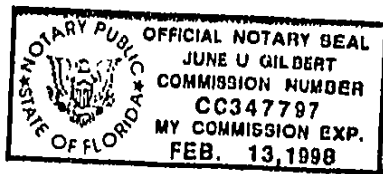


