


Titan Ventures Corporation was administratively dissolved on September 21, 2001, due to not timely filing the Uniform Business Report (UBR) for the company. As your records will reflect, Titan Ventures Corporation filed its UBR each year prior to this year. The 2000 UBR (a copy of which is enclosed) shows that a change of address was filed with this report, however, it appears that this change of address did not get properly recorded in the State's records and Titan Ventures Corporation did not receive its 2001 UBR and was therefore administratively dissolved for not filing its 2001 UBR.

Titan Ventures Corporation is still in business and, at no time, ceased operations. The company has been timely paying sales taxes to the State of Florida of approximately \$50,000 each year since 1999 and continues to do so today. The company has never been late in filing and timely paying its sales tax to the state.

Titan Ventures Corporation respectfully requests, with this Corporate Reinstatement form, that the reinstatement fee of \$600 be abated. The company understands that previous year fees are still due with the acceptance of this filing, however, as the company never received its 2001 UBR form after it changed its address (in the 2000 UBR) we respectfully ask that this reinstatement fee be abated.
