The undersigned, acting as the incorporator of **THE THAYER GROUP, INC.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is: The Thayer Group, Inc.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The principal business office and mailing address of the corporation is 3231 Parkland Boulevard, Tampa, Florida 33609.

ARTICLE III. INITIAL BOARD OF DIRECTORS

The existence of the corporation will commence on March 25, 1997.


