The undersigned, for the purposes of forming a corporation under the Plotida General ALE Corporation Act, hereby adopt the following articles of incorporation:

TALLAHASSEE, FLORIDA

ARTICLE ONE

3-19-97

NAME

The name of the corporation is Furniture Smart, Inc.

ARTICLE TWO

DURATION

The corporation shall commence existence as of the date of execution of these articles. The term of existence shall be perpetual.
