

HOME TEAM OF NORTH FLORIDA, INC., a Florida corporation (the "Corporation"), pursuant to Section 607.1006, Florida Statutes, adopts the following articles of amendment to its articles of incorporation in order to change its name:

1. The name of the corporation is: Home Team of North Florida, Inc.
2. Article I of the articles of incorporation is hereby amended to read as follows:


"The name of the corporation shall be: Falor Home Inspection Services, Inc."
