

ARTICLES OF INCORPORATION

The undersigned, acting as sole incorporator of **Bragassa, Inc.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of incorporation for such Corporation:

ARTICLE I

Name

The name of the Corporation is **Bragassa, Inc.**

ARTICLE II

The effective date of the Corporation shall be upon filing with the Division of Corporations. The duration of this Corporation shall be perpetual.

ARTICLE III

The purpose of this Corporation is to transact any and all lawful business within Florida, and any other state or territory of the United States.

ARTICLE IV

Shares

The number of shares which the Corporation shall have authority to issue is Five Hundred (500), One Dollar (\$1.00) par value per share. In the event that stock other than common is issued, compliance with approved Florida Statutes, will be observed.

ARTICLE V

The address of the Principal Office of the Corporation is 316 Rachelle, # 1125, Sanford, Florida 32771. The location of the Principal Office shall be subject to change as may be provided in bylaws duly adopted by the Corporation.


