Pursuant to the provisions of Chapter 607.1001 et seq. of the Florida Statutes, the undersigned corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is MANATEE TROPICAL LANDSCAPE, INC.
2. The following amendment to the Articles of Incorporation was adopted by the Board of Directors of the corporation on May 6, 1997, in the manner prescribed by the Florida business Corporation Act:

"ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS is hereby amended to indicate that the principal office and mailing address of the corporation shall be 149 E Lucy Dr., Florida City, FL 33034.

3. The shareholders are not required to vote on the amendment to the Articles of Incorporation.
