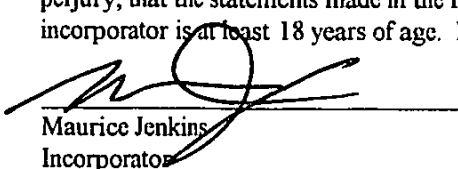
Article VII
