

ARTICLE VII - INCORPORATOR



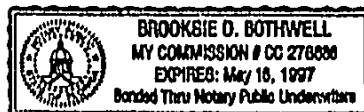
