ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of this Corporation shall be DAVID'S TRADING COMPANY, INC.

ARTICLE II

This Corporation shall exist in perpetuity.

ARTICLE III

The purpose for which the Corporation is organized is for the transaction of any and all lawful business for which Corporations may be incorporated under the Florida Corporation Act.

ARTICLE IV

The initial street address of the principal office of this Corporation in the State of Florida is: 55 E. OSCEOLA STREET, SUITE 100, STUART, FLORIDA 34994.

ARTICLE V

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of one dollar and no cents (\$1.00) per share.

ARTICLE VI

The name of the registered agent is L.LISA BATTS, and the street address of the initial registered agent is 55 E. OSCEOLA STREET, SUITE 100, STUART, FLORIDA 34994.

The Registered Agent hereby affirms that she is familiar with and accepts the duties and responsibilities of Registered Agent for said Corporation.

ARTICLE VII

This Corporation shall have one director initially. The number of directors may be increased or decreased from time to time as set out in the By-Laws of the Corporation, but shall never be less than one director nor more than five. The names and addresses of the directors are:

ARTICLE VIII

ARTICLE IX

ARTICLE X

These Articles of Incorporation may be amended in the manner prescribed by law. Every amendment shall be approved by the

Board of Directors, proposed to them by the Stockholders and approved at a Stockholders's meeting by a majority of the stock entitled to vote thereon, or by one of the Board of Directors and approved by such Board of Directors by a majority thereof, unless all of the Directors and Stockholders sign a written statement and agreement manifesting their intention that a signed statement shall signify their approval of an Amendment to these Articles of Incorporation be made.

ARTICLE XI



This preemptive right is limited to the extent that no fractional shares shall be sold or issued.


