ARTICLES OF INCORPORATION

OF

COLOUR VISION SYSTEMS INC.

ARTICLE I - NAME

The name of the corporation is Colour Vision Systems Inc., (hereinafter called the "Corporation").

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under The Florida Business Corporation Act of the State of Florida.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is 1,000,000 shares of Common Stock, par value \$.001 per share.
