The undersigned, acting as the incorporators of this Corporation pursuant to

Chapter 607 of the Florida Statutes, hereby form a corporation for profit under the laws of the

State of Florida and adopt the following Articles of Incorporation for such Corporation:

<u>ARTICLE I - NAME OF CORPORATION</u>

The name of this Corporation will be Geriatric and Urgent Physician Services, Inc.

ARTICLE II - TERM OF EXISTENCE

This Corporation will exist perpetually, commencing on April 1, 1997.

ARTICLE III - PRINCIPAL OFFICE

The principal office of this Corporation will be located at 801 Orienta Avenue, Suite 2200, Altamonte Springs, Florida 32701.

ARTICLE IV - GENERAL PURPOSE

The general purpose for which this Corporation is organized will be to conduct and transact any and all lawful business authorized or not prohibited by Chapter 607 of the Florida Statutes, as the same may be from time to time amended.

ARTICLE V - CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is Five Hundred (500) shares of common stock having a par value of Ten Dollars (\$10.00) per share.
