ARTICLE I--NAME

The name of this corporation is NOKOMIS FISHING VENTURES, INC.

ARTICLE II--DURATION

This corporation shall exist perpetually.

ARTICLE III--PURPOSE

This corporation is organized for the purpose of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV--POWERS


