The undersigned, acting as the incorporator of the corporation under the Florida Corporation Act, adopts the following Articles of Incorporation for such corporation :

ARTICLE I

NAME: The name of the corporation is RCB ENTERPRISES, INC.

ARTICLE II

REGISTERED OFFICE AND REGISTERED AGENT: The street address of the registered office is 1309 St.Johns Bluff Rd. Nth. Suite 6 Jacksonville, FL 32225.

ARTICLE III

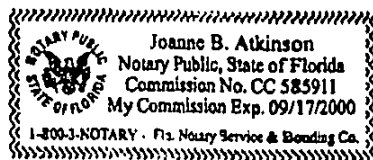
