

The undersigned hereby forms a corporation-for-profit under the Florida General Corporation Act by adopting the following Articles of Incorporation:

1. Name. This corporation's name is Complex Construction Management, Inc.
2. Nature, Purpose and Powers. This corporation shall have perpetual existence, commencing on the date that these Articles are executed and acknowledged. It will have the power to engage in any lawful business and have all powers enumerated in the Florida General Corporation Act.
3. Capital Stock. This corporation is authorized to issue 100,000 shares of \$.10 par value common stock.
4. Initial Registered Agent and Office. The name and address of the initial registered agent of this corporation is: William E. Whitlock, Esq., 610 N. Duval Street, Tallahassee FL 32303.
5. Initial Board of Directors. This corporation shall have two directors initially. 7. Indemnification. The corporation will indemnify any officer or director, or any former officer or director, pursuant to Section 607.014 of the Florida Statutes, as amended.
