ARTICLES OF INCORPORATION
OF
HERBERT B. SCHEVITZ ASSOCIATES, INC.

The undersigned, for the purpose of forming a corporation pursuant to the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:


1. The name of the Corporation is Herbert B. Schevitz Associates, Inc.

Augustine, Florida 32084; and the name of its initial registered agent at such address is Herbert B. Schevitz.


