ARTICLES OF INCORPORATION
OF

Article I - Name

The name of this corporation is G. K. INVESTMENTS, INC.

Article II - Principal Place of Business

Relative Rights of Shares of Capital Stock

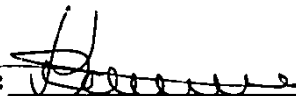
Except as otherwise provided by law, the entire voting power

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

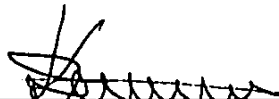
Article XII - Indemnification
