ARTICLES OF INCORPORATION

OF

BIOCLEAN WASTE REDUCTION SYSTEMS SERVICES, INC.

KNOW ALL MEN BY THESE PRESENTS: That the undersigned serson, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be BIOCLEAN WASTE REDUCTION SYSTEMS SERVICES, INC.

ARTICLE II - DURATION OF EXISTENCE

This corporation shall exist perpetually, commencing on the date these Articles are filed in the Office of the Secretary of State.

ARTICLE III - PLACE OF BUSINESS

The corporation's principal place of business shall be 427 Laurel Drive, Margate, FL 33063.

ARTICLE IV - GENERAL PURPOSES
