BANK ARTICLES OF INCORPORATION OF FIRST INTERIM BANK OF TALLAHASSEE

The undersigned, acting as incorporator for the purpose of DA forming a corporation under and by virtue of the Laws of the State of Florida, adopts the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be First Interim Bank of Tallahassee, and its initial place of business shall be at 1997 Capital Circle N.E., in the City of Tallahassee, in the County of Leon, and in the State of Florida.

ARTICLE II

This Corporation shall be organized as a successor institution as defined in Section 658.40(4), Florida Statutes (1995).

ARTICLE III

<u>Section 1</u>. The total number of shares of capital stock authorized to be issued by the Corporation shall be ten (10) shares. Such shares shall be of a single class and shall have a par value of \$75.00 per share.

Section 2. The Corporation shall begin business with at least \$750.00 in paid-in capital stock to be divided into ten (10) shares with a par value of \$75.00 per share. The amount of surplus with which the Corporation will begin business will be not less than \$200.00 and the amount of undivided profits will be not less than \$50.00, all of which (capital stock, surplus and undivided profits) shall be paid in cash.

ARTICLE IV

The term for which said Corporation shall exist shall not exceed one (1) year.

ARTICLE V

The number of directors of the Corporation shall not be fewer than five (5). The names and street addresses of the first directors of the Corporation are:
