ARTICLE I. NAME
The name of the Corporation is LORACYN, INC.

ARTICLE II. DURATION
This Corporation shall have perpetual existence.

ARTICLE III. PURPOSE
This Corporation is organized to transact and carry on any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV. CAPITAL STOCK

1. Number and class of shares authorized: Par Value:

This Corporation is authorized to issue 5,000 shares of voting common stock, having a par value of \$1.00, per share, which shall be designated "common stock."

2. Voting Rights. The common stock shall possess and exercise voting rights and at all meeting of the shareholders, each record holder of common stock shall be entitled to one vote for each share held. Shareholders holding voting common stock shall have no cumulative voting rights in any election of directors of the Corporation.

ARTICLE VII. NO PRE-EMPTIVE RIGHTS

No shareholder of this Corporation shall have the right, upon the sale for cash or otherwise of any new stock of the Corporation or of any stock of the Corporation held by it in its treasury or otherwise, of the same or any kind, class or series which he/she already holds, to purchase his/her pro rata or any other share of such stock at the same price at which it is offered to others or any other price.






