Pursuant of Florida State Law, the undersigned individual submits these Articles of Incorporation for the purpose of forming corporation. If the option is available under the Laws of Florida, the corporation elects to be treated and classified as a close corporation. The corporation will not commence operations until at least \$ 1,000.00 has been received for its shares. The incorporator accepts his appointment as registered agent.

1-The name of the corporation is OXNARD ENTERPRISES, INC.

2-The complete street address and county of the corporation's registered office, and the complete street address and county of the corporation's principle office, and the complete street address and county of the incorporator is 4601 Holly Branch Rd. # 803 , Orlando, Florida 32811 , Orange County.
