The undersigned, for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT, hereby adopts the following Articles of Incorporation:

ARTICLE I
NAME

The name of this corporation is American Radiographic Products, Inc .

DURATION

The term of existence of this corporation is perpetual.

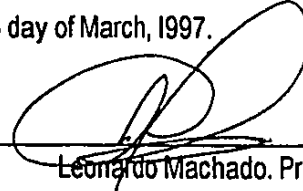

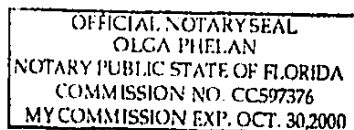
