# ARTICLES OF INCORPORATION OF DOUBLE QUICK SILVER, INC.

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

# ARTICLE I Name

# ARTICLE III <u>Business and Purposes</u>
