The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

<u>Article I</u>

Name

The name of the corporation is R. A. FREY & ASSOCIATES, INC.

Article II

Nature of Business

This corporation is organized for the purpose of offering business consulting services to individuals, corporations and partnerships, and for the purpose of transacting any or all lawful business.

Article III


