ARTICLES OF INCORPORATION OF

BEAUTY FIX BY EVA, INC.

ARTICLE I. NAME

The name of this corporation is Beauty Fix by Eva, Inc.

ARTICLE II. PRINCIPAL OFFICE

The initial street address and principal place of business of the corporation is 6575 Meandering Way, Bradenton, Florida 34202.

ARTICLE III. COMMENCEMENT AND DURATION

This corporation's existence shall commence upon the filing of these Articles of Incorporation. This corporation's duration shall be perpetual.

ARTICLE IV. PURPOSE

This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

ARTICLE VII. INITIAL BOARD OF DIRECTORS

The number of directors on this corporation's Initial Board of Directors shall be one (1). The number of directors may be increased from time to time, as provided in this corporation's bylaws, but shall never be less than one (1).
