## ARTICLES OF INCORPORATION OF AFY RESTAURANT MANAGEMENT, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

<u>Article I. Name and Address</u>. The name and address of the Corporation is: AFY Restaurant Management, Inc., 4610 34th Court East, Bradenton, Florida 34203.

Article 2. Duration. The duration of the Corporation is perpetual.

<u>Article 3. Purpose</u>. The general purposes for which the Corporation is organized are the following:
