#### **ARTICLE 1 - NAME**

The name of the Corporation is SWISS HELVETICA MARKETING, INC., (hereinafter, "Corporation").

- 7.1 The maximum number of shares that this Corporation is authorized to have outstanding at any time is **SEVEN THOUSAND FIVE HUNDRED** (7,500) shares of common stock, each share having the par value of **ONE DOLLAR** (\$1.00).
