ARTICLES OF INCORPORATION
OF

The undersigned incorporators to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be: MASTER BUILDING MAINTENANCE, INC.

ARTICLE II: PRINCIPAL OFFICE ADDRESS

The principal office and mailing address of the corporation shall be located at 8926 Southbay Drive, Tampa, Florida 33615.

ARTICLE III: EXISTENCE

The corporation shall have perpetual existence.

ARTICLE IV: PURPOSE

The nature of the business and the objects and purposes proposed to be transacted, promoted or carried on are to engage in any and lawful business for which corporations may be incorporated under the Florida General Business Corporation Act.

ARTICLE V: CAPITAL STOCK

The corporation is authorized to have at any one time One Hundred (100) shares of common stock, having a par value of one Dollar (\$1.00) per share.

ARTICLE VI: INITIAL REGISTERED OFFICE AND AGENT

The post office address of the corporation's initial registered agent is at 8926 Southbay Dr, Tampa, Florida 33615, and the name of the initial registered agent at such address is Maria A. Duverge.

The board of directors may from time to time change its registered office or its registered agent or both to any other address in the State of Florida.

ARTICLE VII: INITIAL DIRECTORS

The initial Board of Directors shall consist of two (1), and the name and post office address are as follows:

who shall hold office until the first annual meeting of the shareholders, and until their successor shall have been elected and qualified or until their earlier resignation, removal from office or death. The number of Directors may be increased or decreased from time to time by Amendment of the By-Laws, but no decrease shall have the effect of shortening the term of any incumbent Director. The number of Directors shall never be less than one (1).

ARTICLES VIII: INCORPORATOR

ARTICLES IX: AMENDMENTS

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the board of Directors, proposed by them to the shareholders, and approved at a shareholders' meeting by a majority of the stock entitled to vote thereon, unless all the directors and all shareholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made. All rights of shareholders are subject to these reservations.


