**ARTICLES OF INCORPORATION
OF
GREEN SIDE UP OF BRANDON, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following articles of incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be GREEN SIDE UP OF BRANDON, INC.

**ARTICLE II
DURATION**

The term of existence of the corporation shall be perpetual.

**ARTICLE III
PURPOSE**

The corporation is organized for the purpose of providing lawn mowing and maintenance service, and for any other similar related activities, and to transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

**ARTICLE IV
CAPITAL STOCK**

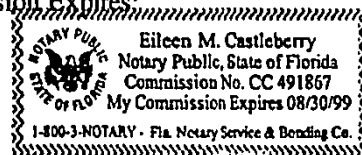
