**ARTICLE I**  
NAME

The name of this corporation shall be Newco Holding, Inc.

**ARTICLE II**  
PRINCIPAL OFFICE AND MAILING ADDRESS

BUSINESS AND PURPOSES

When issued, all shares of stock shall be fully paid and nonassessable.

In either event, the existence of this corporation thereafter shall be perpetual.

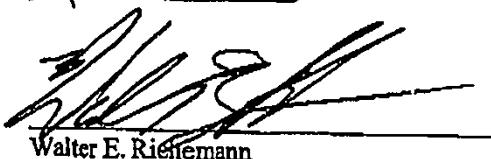
