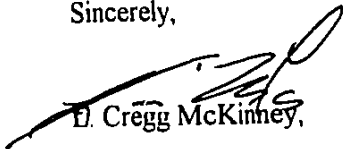

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

Article I. NAME

The name of the corporation shall be: PREFERRED RESOURCE, INCORPORATED.

Directors, subject to any limitations set forth in these Articles of Incorporation. This corporation shall have two directors, initially, whose names and addresses are:

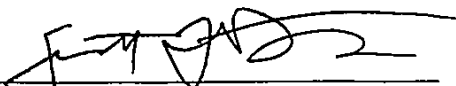

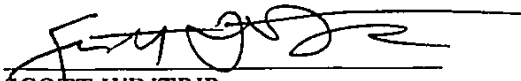
