The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be:

The principal place of business of this corporation shall be 285 W. 49 Street, Hialeah, Florida 33012.

ARTICLE II - NATURE OF BUSINESS

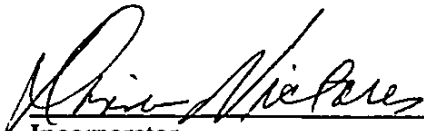

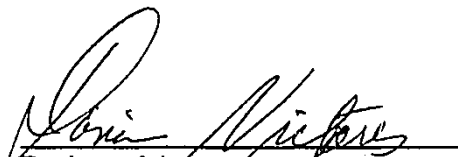
