THE UNDERSIGNED, for the purpose of forming a corporation for profit pursuant to Chapter 621, Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I
NAME OF CORPORATION**

The name of this Corporation shall be:

BANNOURA, HARVAN P.A.

**ARTICLE II
GENERAL NATURE OF BUSINESS**

This corporation may engage in every aspect of the business of rendering the same professional services to the public that an Attorney at Law, duly licensed under the laws of the State of Florida, is authorized to render. -

The general nature of the business to be transacted by this Corporation shall be to engage in the practice of law..

**ARTICLE III
CAPITAL STOCK**

A. The maximum number shares of stock that this Corporation is initially authorized to issue and have outstanding is one thousand (1000) shares of Common Stock having a par value of one dollar (\$1.00) per share. The board of directors shall set forth the relative rights of the common stock. The

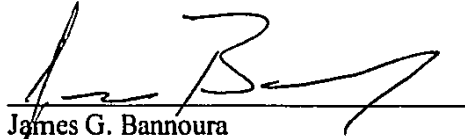
