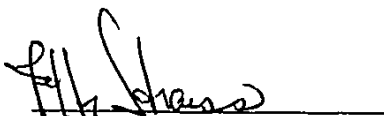

ARTICLE ONE

The name of the corporation is **PLAIN & FANCY, INC.** The principal address of the corporation is: 6251 N. Oriole Boulevard, Delray Beach, Florida 33484.

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**

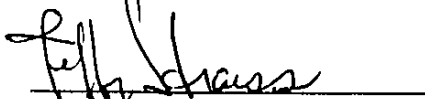
ARTICLE FIVE

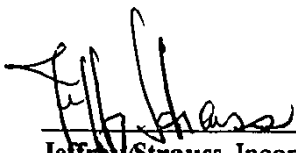
ARTICLE EIGHT
