The undersigned, subscriber to these articles of incorporation, a natural person, hereby presents these articles for the formation of a corporation under Florida law. SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

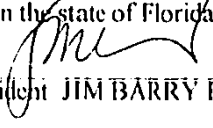

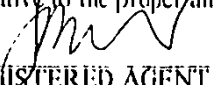
