

ARTICLES OF INCORPORATION

OF

The undersigned incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is: ONE SOURCE REAL ESTATE SERVICES CENTER, INC.
