**SECOND AMENDMENT TO ARTICLES OF INCORPORATION
OF

2. Article X of the Articles of Incorporation of the Corporation is hereby amended as follows:

ARTICLE X - SHAREHOLDERS


Shares of capital stock of this corporation shall be issued initially to the following persons in the amount set forth opposite their name:
