ARTICLES OF INCORPORATION

OF

BROADBAND NETWORK TECHNOLOGY - CONSULTING, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

Name and Duration

The name of the Corporation shall be BROADBAND NETWORK TECHNOLOGY - CONSULTING, INC. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE IV

Corporate Purposes, Powers and Rights

1. The nature of the business to be conducted or promoted and the purposes of the Corporation are:

(a) To specialize in consulting services related to ATM & Frame Relay networking with the following entities:

Corporate Users. Providing advice and support with respect to networking strategies, network design and vendor product selection;

ATM & Frame Relay Networking Vendors. Providing advice and support with respect to product planning, product positioning, marketing strategies, competitive strategies and third party (OEM, distributor, agent) relationship development;

Venture Capital Community. Providing advice and support with respect to company and product positioning and market viability.

(b) To engage in any other lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Florida Business Corporation Act.

ARTICLE V

Capital Stock

The total number of shares of capital stock which the Corporation has the authority to issue is Ten Thousand (10,000) shares of Common Stock ("Common Stock") \$0.01 par value per share.
