ARTICLE I - NAME AND ADDRESS

The name of this corporation is Publicom International Corporation, and the principal address of the corporation is 1450 Coral Way Suite 10 Miami Florida 33145.

ARTICLE II - PURPOSE

This corporation is organized for the transaction of any and all lawful business for which corporations may be incorporated in the State of Florida.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue One Hundred (100) shares of common stock at One Dollar (\$1.00) par value.

ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT
