ARTICLES OF INCORPORATION

of

CASH-A-TITLE, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. The name of the corporation is CASH-A-TITLE, INC.
2. The period of its duration is perpetual.
3. The purpose is to loan or finance any licensed motor vehicle or vessel and any activity or business permitted under the laws of the United States and Florida.

4. The corporation shall have authority to issue sixty (60) shares, all of one class, no par value.

5. The principle address and mailing address of this corporation is 1600 S. Dixie Hwy., West Palm Beach, Florida 33405; and the name of its initial registered agent at said address is ROGER BOUTHILLER.

6. The corporation shall have two (2) directors, and this number can vary from time to time but will never be less than one. The names and addresses of the initial directors, who shall hold the office specified for the first year or until their successor are chosen, shall be:

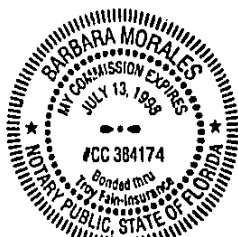


