# ARTICLES OF INCORPORATION OF DE MAYO, Inc.



# ARTICLE\_I - NAME

The name of this corporation is De Mayo, Inc.

# ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

# ARTICLE III - CAPITAL STOCK
